PASTORAL COUNSELING DISCLOSURE STATEMENT

Mission Statement: Crossroads Church exists to SERVE people toward and CONNECT people to Jesus. All spiritual counseling provided is part of Crossroads Church, religious ministry, and is based on religious orientations/viewpoints that support the above mission statement. Spiritual counseling is conducted at Crossroads Church. This ministry is a religious entity holding a 501(C)(3) tax-exempt status.

Provider Disclosure: I am a religious official/minister who is administering only spiritual counseling as part of Crossroads Church, the above religious entity. I am a member and hold a position of trusts within this ministry. The Pastoral spiritual direction provided is spiritual guidance and prayer and is not intended to take the place of diagnostic or formal therapy. Your insurance shall not be billed. If you feel you are in need of formal counseling and/ or a diagnosis for any mental health condition, you should seek professional counseling. If professional counseling or psychotherapy are desired, please see a licensed professional counselor or a licensed psychotherapist.

Confidentiality: Generally, the information disclosed during a pastoral counseling session is confidential. As such, the pastor cannot be forced to disclose the information without the congregant's consent. There are exceptions to the general rule of legal confidentiality. These exceptions deal with past or present physical or sexual abuse of a child, incompetent, or disabled person, or immediate threats of physical harm to you or another person, or in a criminal or delinquency proceeding. If abuse or neglect is disclosed, the Pastor is mandated by Colorado law to report such information to the appropriate state agency. Also, a pastor may be under on-going supervision from another pastor or working closely with another pastor(s) with whom the content of the counseling sessions could be shared.

Fee/Donation Structure: There is no fee for Pastoral Counseling at Crossroads Church.

Client's Rights:

- * The client is entitled to receive information about the methods of spiritual counseling, the techniques used, and the duration of spiritual counseling.
* The client may seek a second opinion from another provider or may terminate services at any time.
* In a professional relationship, sexual intimacy is never appropriate.
